Opinion

We have audited the accompanying financial statements of the Richmond-Santa Rosa-Vallejo Newspaper Guild Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), the related statements of changes in net assets available for benefits for the years then ended, the statement of accumulated benefits as of December 31, 2022, the related statement of changes in accumulated benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the changes in its net assets available for benefits for the years then ended, and the accumulated benefits as of December 31, 2022, and the changes in its accumulated benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of a Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 5 to the financial statements, the Board of Trustees approved a plan of liquidation and termination on May 1, 2024. As a result, the Plan changed its basis of accounting from the accrual basis used in presenting the December 31, 2022 financial statements to the liquidation basis of accounting used in presenting the December 31, 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the

design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTE 1 - DESCRIPTION OF THE PLAN

The Richmond-Santa Rosa-Vallejo Newspaper Guild Retirement Plan (the "Plan"), a multiemployer defined benefit plan, was established on January 1, 1960 by the San Francisco-Oakland Newspaper Guild (the "Guild") and various publishers of newspapers in the San Francisco Bay Areas. In January 2011, the Guild was renamed Pacific Media Workers Guild ("PMWG"). The Plan is a defined benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Participants are entitled to annual pension benefits when they reach normal retirement age or accumulate sufficient period of service. The Plan provides two types of retirement benefits: basic pension benefits payable at the normal retirement age of 65 and supplemental pension benefits payable to an eligible participant upon retirement, disability, or termination of employment, provided that the participant has a vested benefit.

On November 9, 2012, the Plan experienced the withdrawal of its last remaining contributing employer; therefore, no contributions are required under the collective bargaining agreements and no further benefit accruals under the Plan. However, the Plan continues to pay benefits.

On December 19 and 20, 2023, the Board of Trustees purchased annuity contracts from two insurers, American United Life Insurance Company ("OneAmerica") and Principal Life Insurance Company ("Principal") for all Plan participants and beneficiaries for the payment of benefits under the Plan.

On April 17, 2024, the Board of Trustees voted to terminate the Plan effective May 1, 2024, for purposes of closing out and winding up the Plan and Trust.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are recorded on the liquidation basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions and Withdrawal Liability Receivable

The Board of Trustees established a funding policy and method in order to promote the purpose of the Plan and to ensure compliance with ERISA. On November 9, 2012, the Plan terminated by the withdrawal of its last remaining employer. The employer was assessed a withdrawal liability of \$6,728,925. The employer makes quarterly payments of \$133,272. As of December 31, 2022, the Plan's withdrawal liability receivable was \$2,754,997. During

2023, the Plan received three quarterly payments from the employer. During 2023, the Plan and employer reached a settlement agreement of the withdrawal liability. Under this agreement, the employer paid the Plan \$1,950,000 to settle the liability in full. The Plan wrote off the remaining balance of the outstanding receivable and recorded this as withdrawal liability expense on the statements of changes in net assets available for benefits.

D. Tax-Exempt Status

The Plan received its latest notice of tax-exempt status on August 13, 2015. The Plan administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for federal or state income tax is made.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

E. Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of accumulated plan benefits is determined by an actuary and is the amount that results from applying actuarial assumptions to adjust accumulated plan benefits to reflect the time value of money and the probability of payment between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used in the latest valuation as of December 31, 2022 are: (a) investment earnings at 4.00% per year, (b) life expectancy of participants using the 2022 PBGC prescribed mortality table for terminated plans, (c) operating expenses assumed to be equal to the prior years actual administrative expenses with 2% increase for inflation, (d) husbands assumed to be the same age as wives and non-retired participants assumed to be married, and (e) assumed retirement age of 65.

The changes to the actuarial assumptions from the prior year were as follows; the discount rate was changed from 2.40% for the first 20 years and 2.11% thereafter, to 3.90% for the first 20 years and 3.65% thereafter, and the mortality table was changed from the 2021 PBGC prescribed mortality table for terminated plans to the 2022 PBGC prescribed mortality table for terminated plans.

The foregoing actuarial assumptions and methods were based on the presumption that the Plan would continue to operate as an ongoing Plan. However, the Plan has since purchased annuities for all participants. As of December 31, 2023, there is no actuarial present value of accumulated plan benefits for the Plan.

For the year ended December 31, 2022, the Plan was certified by the actuary not to be in the critical or endangered status. There was no certification required for the Plan year ending December 31, 2023.

NOTE 3 - PURCHASE OF ANNUITIES FOR PARTICIPANTS

On December 19 and 20, 2023, the Board of Trustees purchased annuity contracts from two insurers, OneAmerica and Principal for all Plan participants and beneficiaries for the payment of benefits under the Plan. The cost of purchasing these annuities was \$13,051,501.

NOTE 4 - PLAN TERMINATION

On April 17, 2024, the Board of Trustees voted to terminate the Plan effective May 1, 2024, for purposes of closing out and winding up the Plan and Trust. The administrator shall pay all of the administrative expenses of the Plan to wind up the Plan as promptly as possible. Any remaining assets of the Plan will be distributed to all participants of the Plan receiving or eligible to receive an annuity from OneAmerica or Principal as of the date of the Plan's termination.

NOTE 5 - RELATED PARTY TRANSACTIONS

PMWG, a related party employee organization, provides administrative services to the Plan. During the years ended December 31, 2023 and 2022, the Plan paid PMWG \$15,000 and \$15,202, respectively, for these services.

Plan investments are managed by Principal Life Insurance Company ("Principal"), the custodian of the Plan. Investment advisory fees paid for the years ended December 31, 2023 and 2022 were \$51,977 and \$59,857, respectively.

NOTE 6 - INVESTMENT VALUATION AND INCOME RECOGNITION

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan is invested in pooled separate accounts reported at net asset value or its equivalent. In accordance with ASC 820, investments measured at net asset value per share (or its equivalent) are not classified in the fair value hierarchy.

Pooled separate accounts are investment vehicles established and maintained by an insurance company. The underlying investments of the pooled separate accounts are publicly traded equities reported at fair market value based on their published price on an active market. The investment objective of the pooled separate accounts vary based on the investment strategy of the account and its underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Realized and unrealized gains and losses are computed using investments' carry values for financial statement purposes. For Form 5500 reporting, realized and unrealized gains and losses are computed using investments' market values as of the beginning of the year.

NOTE 7 - RISKS AND UNCERTAINTIES

The actuarial present value of accumulated plan benefits is calculated based on certain assumptions pertaining to interest rate, participant demographics and other assumptions, all of

which are subject to change. Due to the inherent uncertainty of the assumption process, it is at least reasonably possible changes in these assumptions in the near term would be material to the disclosure in the financial statements of actuarial present value of accumulated plan benefits.

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some values may differ from values that would have been used had a ready market existed for the investment. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risks in the near term would materially affect the amounts reported in the financial statements.

NOTE 8 - SUBSEQUENT EVENTS

Management of the Plan has evaluated subsequent events through September 30, 2024, the date on which the financial statements were available to be issued. Other than noted in Notes 1 and 4, there were no material subsequent events that required recognition or additional disclosures in these financial statements.
